#### **Driving forces**

The telecommunications industry operates in a highly competitive, albeit heavily regulated environment, where exposure to antitrust regulation is pronounced. To remain competitive in a market consistently subject to rapid technological change, companies need to adopt efficient and flexible business models. This helps them integrate next-generation technologies, such as 5G and the forthcoming 6G which will use cognitive technologies like AI to enable low-latency, highspeed communication. New business models also need to produce innovative solutions to social and environmental issues. The increased use of smart devices has led consumers to pay more attention to data privacy. Insufficient database and network protection, applying internationally recognised standards, could further expose companies to reputational and legal risks. Cybersecurity and physical threats to network infrastructure, including extreme weather events, can have significant economic impacts. Investing in data security and upgrading network infrastructure is critical.
